- **ON COMPUTER: CTRL + H + SELECT ANY REFERENCE TO THIS GUIDE OR IF QUICKER, CLEAR HISTORY FOR THE LAST HOUR**

DOMESTIC VIOLENCE AND ABUSE IS: ANY INCIDENT OR PATTERN OF INCIDENTS OF CONTROLLING, COERCIVE, THREATENING BEHAVIOUR, VIOLENCE OR ABUSE BETWEEN THOSE AGED 16 OR OVER WHO ARE, OR HAVE BEEN, INTIMATE PARTNERS OR FAMILY MEMBERS REGARDLESS OF GENDER OR SEXUALITY.

WHATEVER YOU TICKED, NAMING WHAT IS HAPPENING TO YOU MATTERS. NOT FOR ANYONE ELSE. FOR YOU. BECAUSE WHEN YOU CAN PUT A NAME TO IT, YOU CAN BEGIN TO UNDERSTAND IT FOR WHAT IT IS.

GET MONEY

NO 1. RULE TO CARRY INTO ANY RELATIONSHIP: **ALWAYS HAVE YOUR OWN MONEY. RELATIONSHIPS CAN BECOME COMFORTABLE BUT A FINANCIAL SAFETY NET IS ALWAYS A MUST. IF YOU'VE NOT BEEN ABLE TO HANG ONTO YOUR SAFETY NET, THIS PAGE IS HERE TO HELP YOU RESTART OR START.**



**WHERE CAN

KEEP SOME
MONEY?**

YOU CAN SET UP A BANK ACCOUNT REMOTELY QUICK AND EASY WITH JUST A FORM OF ID AND ADDRESS, SOME OF THE LISTED BANK ACCOUNTS IN THE MONEY SECTION OF THIS GUIDE WON'T EVEN REQUIRE AN ADDRESS.

CHECK FOR A PAPERLESS OPTION AND VIRTUAL CARD ON YOUR MOBILE IF YOU DON'T WANT ANYTHING COMING TO YOUR ADDRESS

SAVING ANY AMOUNT AT A TIME IS GOOD, EVEN IF IT'S JUST £1

IF OPENING A BANK ACCOUNT COULD PUT YOU AT RISK BECAUSE YOUR DEVICE OR FINANCES ARE MONITORED, TRY ACCESSING BANKING SERVICES FROM A SAFE DEVICE SUCH AS A FRIEND'S PHONE, A LIBRARY COMPUTER, OR WITH HELP FROM A REFUGE OR SUPPORT WORKER

GET OUT

HOW TO GET OUT OF THE HOME WITHOUT THE ABUSER FINDING OUT?



GET TO A WOMEN'S REFUGE. TRY TO HAVE A TO GO-BAG READY SO YOU COULD LEAVE IN AN INSTANT. IF THAT IS NOT AN OPTION KNOW WHERE YOUR IDS ARE AND TRY TO GET A SPARE CHARGER FOR YOUR PHONE.

A REFUGE IS A SAFE HOUSE TO ESCAPE DOMESTIC ABUSE OF ALL TYPES. YOU DON'T NEED TO HAVE EXPERIENCED PHYSICAL ABUSE TO STAY IN A REFUGE. REFUGES ARE OPEN TO WOMEN ON THEIR OWN AND ALSO WITH THEIR CHILDREN.

HOW CAN I BE PUT IN TOUCH WITH A REFUGE?

THEY CAN HELP FIND YOU A REFUGE SPACE ANYWHERE IN THE UK, BASED ON YOUR LOCATION AND SITUATION.

YOUR LOCAL AUTHORITY ALSO HAS A DUTY TO PROVIDE ACCOMMODATION TO ANYONE EXPERIENCING DOMESTIC ABUSE. PLACES ARE LIMITED AND DEMAND IS HIGH, SO CONTACT THEM AS EARLY AS POSSIBLE. YOU CAN FIND YOUR LOCAL AUTHORITY BY SEARCHING YOUR POSTCODE

THE COURT WILL CHECK YOU UNDERSTAND WHAT YOU'RE ASKING FOR, THEN DECIDE IF YOU CAN GO AHEAD WITH JUST A SOLICITOR OR IF A TRUSTED ADULT, LIKE A PARENT OR SOCIAL WORKER, NEEDS TO BE COURT-APPROVED TO ACT FOR YOU. NON-MOLESTATION ORDER

WHAT CAN IT DO FOR ME?

A NON-MOLESTATION ORDER IS A COURT ORDER THAT HELPS PROTECT YOU AND YOUR CHILD FROM ABUSE, HARASSMENT, OR THREATS.

IT CAN PLACE LEGAL RESTRICTIONS ON THE ABUSER, SUCH AS STOPPING THEM FROM CONTACTING YOU, COMING NEAR YOUR HOME OR WORKPLACE, OR BEHAVING IN A WAY THAT CAUSES YOU DISTRESS.

HOW DO I APPLY FOR A NON-MOLESTATION ORDER?

BY FILLING IN FORM FL401. THE FL401 FORM IS THE APPLICATION THAT ASKS THE COURT FOR PROTECTION. YOU COMPLETE IT FIRST AND THEN SEND IT TO THE COURT. THIS CAN BE DONE ONLINE.

WHERE DO I GET THE FORM ?

IF YOU THINK YOU'LL STRUGGLE WITH THIS, CHECK THE MONEY SECTION FOR LEGAL REPS INFO.



WILL MY ABUSER BE NOTIFIED ABOUT THE NON- MOLESTATION ORDER?



ONCE THE ORDER IS GRANTED, IT MUST BE SERVED ON THE ABUSER BEFORE IT CAN BE ENFORCED.

A PROCESS SERVER IS USUALLY USED TO DELIVER THE COURT-SEALED ORDER TO THEM.

THIS MEANS THE ABUSER HAS OFFICIALLY RECEIVED THE ORDER AND MUST FOLLOW WHAT IT SAYS.

NON-MOLESTATION ORDERS CAN BE MADE WITHOUT NOTICE TO THE ABUSER.

ON THE FL401 FORM, MAKE SURE TO TICK “WITHOUT NOTICE” IF YOU ARE AT RISK OF HARM, INTIMIDATION, OR THE SITUATION ESCALATING. THIS MEANS THE ABUSER WILL NOT BE TOLD ABOUT THE APPLICATION BEFORE THE JUDGE MAKES A DECISION.

CONSULT A LEGAL PROFESSIONAL. CHECK THE MONEY SECTION FOR HELP ON THIS.

HOW LONG CAN A NON-MOLESTATION ORDER BE ENFORCED FOR?

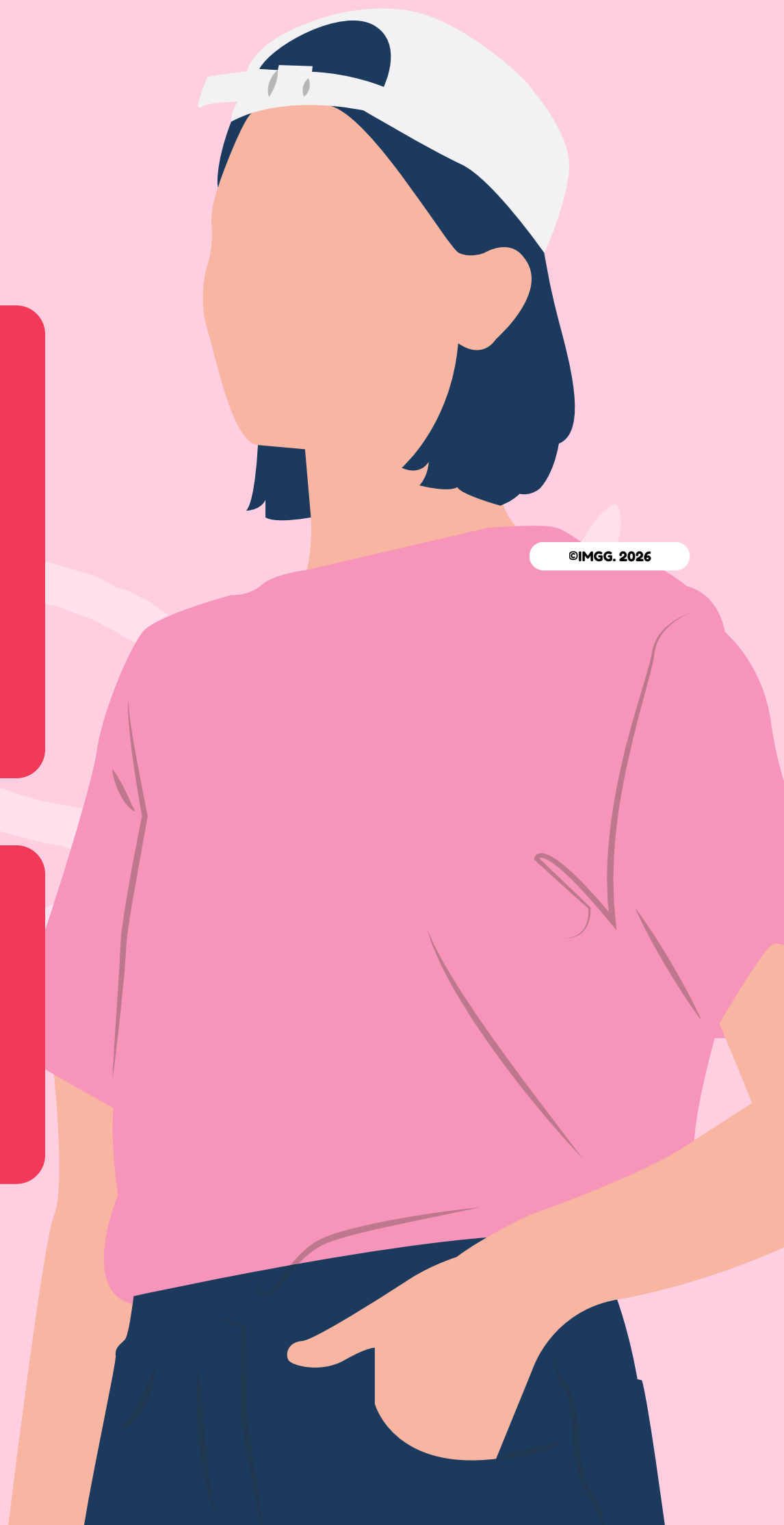
CAN OFTEN BE FOR AROUND 6–12 MONTHS, BUT THE COURT CAN MAKE THEM LONGER.

THIS CAN BE EXTENDED IF YOU APPLY TO DO SO.

WHAT IF MY ABUSER BREACHES THE ORDER?

IF YOUR ABUSER BREACHES THE NON-MOLESTATION ORDER IT IS A CRIMINAL OFFENCE.

MEANING IT CAN RESULT IN IMPRISONMENT OR A FINE.

OCCUPATION ORDER

WHAT CAN THE ORDER DO FOR ME AND HOW CAN I GET IT?



IT CAN DETERMINE WHO CAN LIVE AT THE PROPERTY AND CAN EXCLUDE YOUR ABUSER FROM THE HOME OR PART OF THE HOME.

BY FILLING IN THE FORM FL401 BUT FIRST, DETERMINING WHETHER YOU MIGHT BE ELIGIBLE.

ASK YOURSELF THESE QUESTIONS

I AM 18+ AND HAVE EXPERIENCED EITHER PHYSICAL, EMOTIONAL, FINANCIAL OR PSYCHOLOGICAL HARM?

AND

I AM 18+ AND EITHER A CO-OWNER OF THE PROPERTY, NAMED ON THE TENANCY AGREEMENT, A SPOUSE OR CIVIL PARTNER OF THE PROPERTY OWNER?

YOU MAY BE ABLE TO MAKE AN OCCUPATION ORDER.

- **WOULD LIVING WITH THIS PERSON HARM YOUR HEALTH, SAFETY, OR WELLBEING (OR THAT OF YOUR CHILD)?**
- **HAS THIS PERSON TREATED YOU BADLY, THREATENED YOU, OR BEHAVED ABUSIVELY?**
- **HAVE YOU AND THIS PERSON ALREADY STOPPED LIVING TOGETHER?**
- **ARE YOU DIVORCED OR HAS YOUR CIVIL PARTNERSHIP ENDED?**
- **ARE THERE ALREADY COURT CASES BETWEEN YOU ABOUT MONEY, PROPERTY, OR DIVORCE?**

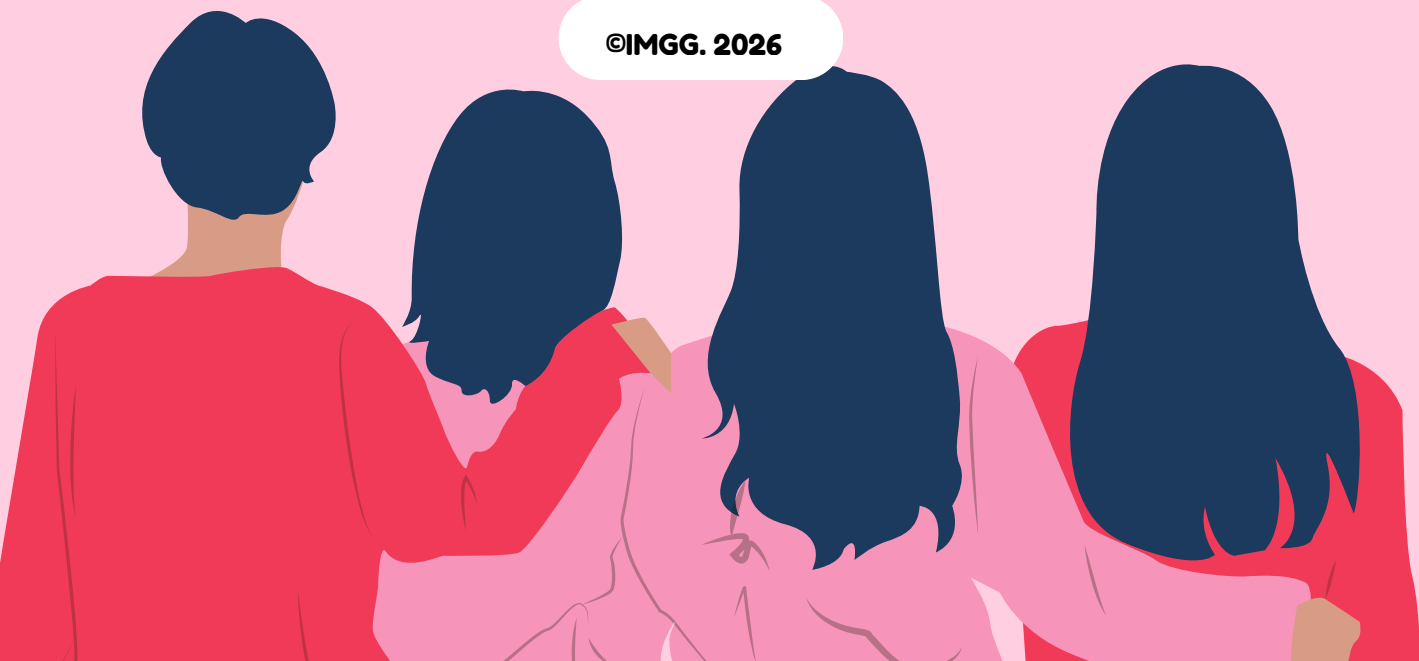
**YOU CAN APPLY FOR THE ABOVE ORDER
AT 16 OR 17. THE COURT WILL CHECK YOU
UNDERSTAND WHAT YOU'RE ASKING FOR,
THEN DECIDE IF YOU CAN GO AHEAD WITH
JUST A SOLICITOR OR IF A TRUSTED ADULT,
LIKE A PARENT OR SOCIAL WORKER, NEEDS

HOW LONG CAN AN OCCUPATION ORDER BE ENFORCED FOR?

OCCUPATION ORDERS ARE USUALLY MADE FOR SEVERAL MONTHS AND CAN SOMETIMES BE EXTENDED DEPENDING ON THE CIRCUMSTANCES. USE A PROCESS SERVER TO SERVE THE ABUSER THE PAPERS, DO THIS **AS SOON AS POSSIBLE**. ANY MORTGAGEE OR LANDLORD MUST ALSO BE NOTIFIED.

WHAT WILL HAPPEN IF THE ABUSER BREACHES THE ORDER?

BREACHING THE OCCUPATION ORDER IS NOT A CRIMINAL OFFENCE.

BUT YOU CAN REQUEST THAT A POWER OF ARREST BE ATTACHED TO THE ORDER, MEANING POLICE CAN AUTOMATICALLY ARREST THE ABUSER WITHOUT THE NEED FOR A FURTHER APPLICATION TO COURT.



OTHER PROTECTIONS

DAPO

A DOMESTIC ABUSE PROTECTION ORDER IS A LONGER-TERM PROTECTION FOR VICTIMS AND CAN BE APPLIED FOR IN RELATION TO ALL FORMS OF DOMESTIC ABUSE.

AN ORDER MAY PREVENT A PERPETRATOR FROM RETURNING TO THE HOME OR HAVING CONTACT WITH THE VICTIM.

IF THE ABUSER BREACHES THE DOMESTIC ABUSE PROTECTION ORDER IT IS A CRIMINAL OFFENCE BUT CAN ALSO BE DEALT WITH AS A CONTEMPT OF COURT.

DEPENDING ON WHERE YOU LIVE DAPO CAN BE REFERRED TO AS DVPO

PLEASE NOTE: DAPOS AND DAPNS ARE CURRENTLY ONLY AVAILABLE IN GREATER MANCHESTER AND PARTS OF SOUTH LONDON (CROYDON, SUTTON AND BROMLEY), CLEVELAND AND NORTH WALES: IF YOU ARE OUTSIDE THESE AREAS, A NON-MOLESTATION ORDER IS CURRENTLY YOUR MOST ACCESSIBLE OPTION.

OTHER PROTECTIONS

DAPN

A DOMESTIC ABUSE PROTECTION NOTICE CAN BE ISSUED BY A SENIOR POLICE OFFICER AND CAN REQUIRE A PERSON REASONABLY SUSPECTED OF BEING ABUSIVE TO A CONNECTED PERSON OVER THE AGE OF 16, TO LEAVE THE VICTIM'S HOME FOR UP TO 48 HOURS, NOT CONTACT THE VICTIM AND NOT COME WITHIN A SPECIFIED DISTANCE OF THE HOME.



IF THERE HAS BEEN A BREACH OF THE NOTICE, THE PERSON SUBJECT TO THE NOTICE CAN BE ARRESTED WITHOUT A WARRANT

DEPENDING ON WHERE YOU LIVE DAPN CAN BE REFERRED TO AS DVPN
